2020 Extras Charges

Extras charges are the additional fees over and above the Tuition fee and include a Year Levy for compulsory charges and other charges for discretionary activities. The Year Levy includes excursions, incursions, camps, elective subject fees, swimming and athletics carnivals that apply to all students in each year group. The amounts per year group are:

Parents' Association Levy:

Currently \$ 96 per annum \$24 per term
