Hi Victoria,

I just wanted to clarify a couple of points from our perspective.

The DRAFT Landscape Master Plan / Opportunities and Constraints Plan is an excerpt from a 27 page document. There may be various other pages which give you a better feel of the landscape character that we're proposing.

When we refer to totems we are not talking about "poles" and we're not necessarily talking about sculptures, paintings or other physical representations of totems. We're trying to promote a living landscape that is welcoming and identifies with the spirit of the local totems such as the eel, cockatoo and goanna.

Also please see attached draft Landscape site analysis plan, where Arterra proposes:


- PRIMARY SCHOOL Nature play with possible Darug totems
